January 25, 1932 - January 22, 2013

Charles (Chuck) Lamb, 80, of Bolivar passed away Tuesday, January 22 at his residence. He was one of 6 sons born to Charles Curtis and Martha Ruth Wilson Lamb Sr., in Lawrence, Kansas. Chuck served in the U.S. Army during the Korean War and upon discharge began a 44 year career as a railroad dispatcher, first for the Rock Island Railroad and then the Union Pacific Railroad. He married Genny Guest on July 2, 1955 and they celebrated 57 years of marriage together. They moved to Bolivar in 1992 coming here from Council Bluffs, Iowa. Charles had many interests, he loved fishing and gardening where he produced abundant produce each summer. He enjoyed collecting rocks and doing genealogical research. He was honored as Jaycee Coach of the Year while coaching his son and daughter to become National Champion BB marksman. He was a member of NAV, the National Association of Retired and Veteran Railway Employees, American Legion, and was a President of the Ozark Mountain Leather Guild. His special joys were his grandchildren, great-grandchildren, and watching out for his neighbors, helping them with their chores. Preceding him in death were his parents, brother Merle, his son Curtis Alan Lamb, and mother-in-law Geneva Robison.
