Norma "Jeane" Emmert passed away on Friday, December 19, 2014 at her home in Bolivar, Missouri, surrounded by her family after a lingering illness.

Born January 31, 1935 in Bolivar, Missouri, the only child of Charles Washington May and Ollie Batrice Martin May, Jeane was 79 years, 10 months and 19 days of age.

On November 14, 1958, she eloped with Glen Doran Emmert of Morrisville to Miami, Oklahoma. They were married 46 years when Doran died in 2005. In 1967, they adopted an infant daughter, Shelley Ann, and an infant son, Scott Glen joined the family in 1972. Together Shelley and Scott gave them six grandchildren.
